Development Bank of Seychelles (Southern Africa and Indian Ocean) (SMERF) Guarantee Order, 2020

In exercise of the powers conferred by section 28 of the Public Debt Management Act, the Minister responsible for Finance makes the following Order —

1. This order may be cited as the Development Bank of Citation Seychelles (Southern Africa and Indian Ocean) (SMERF) Guarantee Order, 2020.

2. The Minister responsible for Finance has, in The Loan accordance with the provision in section 14 of the Public Debt Management Act, guaranteed a loan on behalf of the Development Bank of Seychelles from European Investment Bank under a Finance Contract and First Demand Guarantee Agreement dated 10th September, 2019 the particulars of which are stated in paragraph 3

3. The particulars of the Finance Contract and First Particulars Demand Guarantee Agreement referred to in paragraph 2 are as follows —

(a)	Amount Guarantee:	Ten Million Euros (EUR 10,000,000);
