#### EMPLOYMENT ACT

(Cap 69)

#### **Employment Act (Exemption) Order, 2025**

In exercise of the powers conferred by section 4(2) of the Employment Act, the Minister responsible for Employment and Social Affairs makes the following Order —

#### Citation

1. This Order may be cited as the Employment Act (Exemption) Order, 2025.

# **Exemption**

2. A person specified in column 1 of the Schedule is exempt from the application of the Regulation specified in column 2 for the maximum additional hours as specified in column 3 thereof.

### **Exemption of Employer**

**3.** Where a worker is exempted from a provision of the Regulation specified in column 2 of the Schedule, the employer of that worker is exempt from the application of the provision subject to the limit specified in column 3 thereof

#### **Conditions of Exemptions**

**4.** The exemptions under this Order shall be subject to the following conditions specified in column 3 of the Schedule.
