Notification of proposed reclamation within Petit Paris Lagoon At Cascade under subsections (2) and (3) of section 6 of the Land Reclamation Act (Cap. 106)

WHEREAS, United Concrete Products (Seychelles) Limited (UCPS) acting on its own behalf (hereinafter referred to as “the Applicant”) has applied for authorisation under section 6 of the Land Reclamation Act (Cap. 106) to fill in and reclaim an area of foreshore of approximately 29, 267 square metres within the Petit Paris Lagoon at Cascade, Mahe, adjacent to a strip of land along the public highway (hereinafter referred to as “the Undertaking”);

AND WHEREAS, the Undertaking is demarcated by the coordinates specified in the Schedule of this notification and the Plan hereunder attached are available for inspection at the Seychelles Planning Authority's Office at Independence House and may also be viewed on its website at www.spa.gov.sc;

AND WHEREAS, the Undertaking also provides for an excavation area of a maximum width and depth of 30 metres and -4 metres above Chart Datum respectively as shown in blue colour on the Plan hereunder to provide for a navigational channel for all tides access by boat owners and fishermen in the area;

AND WHEREAS, the Applicant has agreed to the terms and conditions that in consideration of the Applicant carrying out the Undertaking at its own costs, the Applicant shall transfer approximately 776 square metres of land, owned by the Applicant, situated at Pointe Larue, in order to facilitate the implementation of the Third Lane Project to reduce traffic congestion in that area. The land to be transferred will be exercised from the following parcels:

- 319 sqm from parcel S418
- 22 sqm from parcel S419
- 286 sqm from parcel S526
- 114 sqm from parcel S631
- 11 sqm from parcel S1386; and
- 24 sqm from parcel S377;

AND WHEREAS, the Republic has agreed that upon completion of the Undertaking, it will transfer two portions of land marked UCPS PLOT 1 and UCPS PLOT 2 having a total area of 17569 square metres as shown on the Plan hereunder at no cost to the Applicant, representing approximately 60% of the total area reclaimed. The Republic shall retain ownership of the portion of land marked GOS, totaling an area of 11700 square metres, as shown on the Plan hereunder, at no cost to it, representing approximately 40% of the total area reclaimed;

AND WHEREAS, the President is desirous of authorising the reclamation of the Undertaking or the performance of other works over and upon the foreshore specified in the Schedule of this notification and the Plan illustrated hereunder by the Applicant;

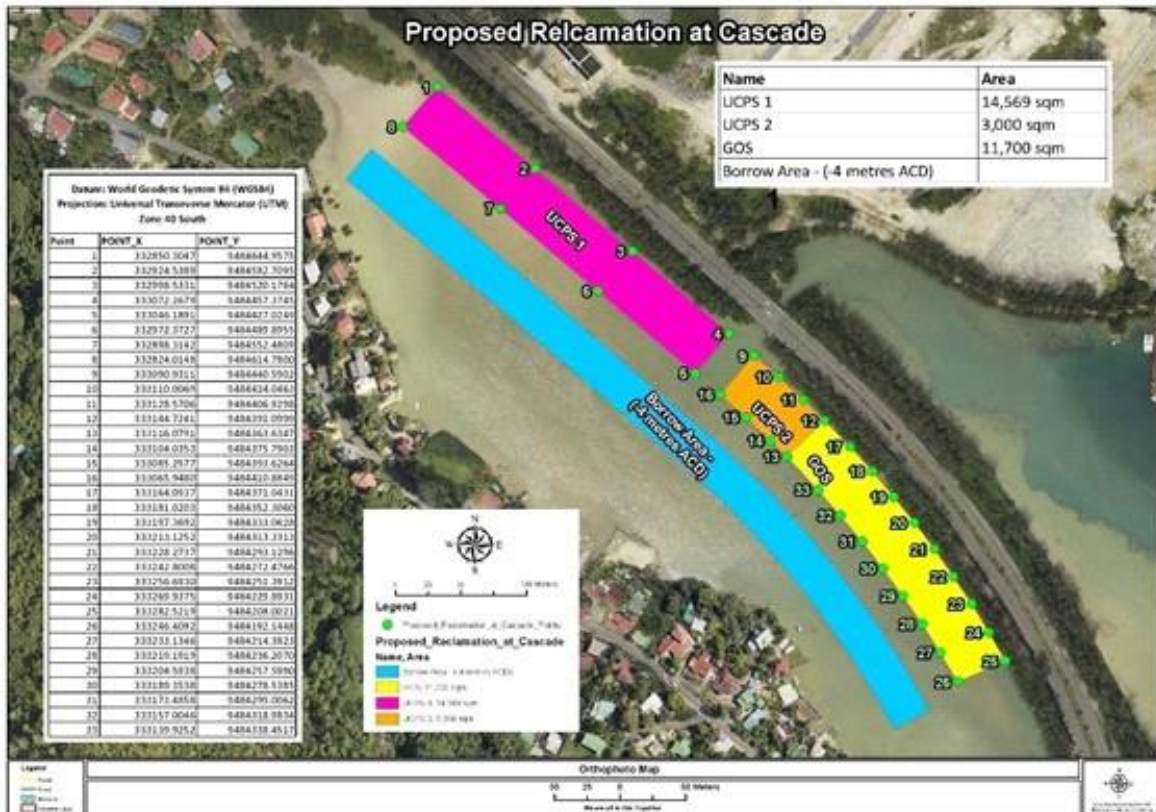
