**S.I. 18 of 2025****NATURE RESERVES AND CONSERVANCY ACT***(Act 3 of 2022)***Nature Reserves and Conservancy (Seychelles Marine Spatial Plan) Regulations, 2025**

In exercise of the powers conferred by section 32 of the Nature Reserves and Conservancy Act 2022, the Minister responsible for environment makes the following regulations —

**Citation**

1. These regulations may be cited as the Nature Reserves and Conservancy (Seychelles Marine Spatial Plan) Regulations, 2025.

**Interpretation**

2. In these regulations, unless the context otherwise requires —

“Act” means the Nature Reserves and Conservancy Act, 2022;

“Boundary of the Seychelles Marine Spatial Plan” is from the mean high water mark seaward to the outer boundary of the Exclusive Economic Zone;

“Deep water” means the waters of a depth of 200 meters or more that are not within Zone 1, Zone 2, or the Inner Islands area;

“Exclusive Economic Zone/EEZ” means the Exclusive Economic Zone of Seychelles, as defined in section 9 read with section 13 of the Maritime Zones Act, 1999

“Map of the Seychelles Marine Spatial Plan” means the map titled

“Seychelles Marine Spatial Plan Milestone 3” dated 26 March

2020 deposited at the documentation centre of the ministry responsible for environment.

“Mean high water mark” means the line of mean high tide between the ordinary high-water spring and ordinary high-water neap tides;

“Minister” means the Minister responsible for Environment and Ministry shall be construed accordingly;

“Port of Victoria boundary” means the area as defined in section 15 of the Seychelles Ports Authority (Amendment) Act, 2024;

“Seychelles Marine Spatial Plan document” means the document titled “Seychelles Marine Spatial Plan” deposited at the documentation centre of the Ministry responsible for the environment, as approved by the Cabinet;

“Seychelles Marine Spatial Plan area” means the area that covers the EEZ of the Seychelles and comprises “Zone 1 areas”, “Zone 2 areas,” and the “Zone 3 areas”, excluding Aldabra Special Reserve, Aride Island Special Reserve, Cousin Island Special Reserve, St. Anne Marine National Park, Baie Ternay Marine National Park, Curieuse Marine National Park, Port Launay Marine National Park, Ile Cocos, Ile La Fouche, Ile Platte Marine National Park and Silhouette Marine National Park;

“Territorial sea” means the territorial sea of Seychelles, as defined in section 4 of the Maritime Zones Act, 1999;

“Vessel” has the meaning assigned by the Seychelles Ports Authority (Amendment) Act, 2024; “Zone 1” means Seychelles Marine Spatial Plan High Biodiversity Protection zone as described in the Seychelles MSP Zoning Framework set out in Schedule 5 and consists of the following areas —

- (a) Aldabra Group Marine National Park as designated by the National Parks (Aldabra Group) (Marine) (Designation) Order, 2020 S.I. 52 of 2020;

- (b) Bird Island Ile Aux Vaches National Park as designated by the National Parks (Bird Island) (Ile aux Vaches) (Marine) (Designation) Order, 2020, S.I. 53 of 2020;
- (c) Amirantes South Marine National Park as designated by the National Parks (Amirantes South) (Marine) (Designation) Order, 2020, S.I. 54 of 2020;
- (d) D'Arros to Poivre Atolls Marine National Park as designated by the National Parks (D' Arros to Poivre Atolls) (Marine) (Designation) Order, 2020, S.I. 55 of 2020; and
- (e) D'Arros Atoll Marine National Park as designated by the National Parks (D' Arros Atoll) (Marine) (Designation) Order, 2020, S.I. 56 of 2020.

“Zone 2” means Seychelles Marine Spatial Plan medium biodiversity protection and sustainable use zone as described in the Seychelles MSP Zoning framework set out in Schedule 5 and consists of the following areas —

- (a) Alphonse Group Sustainable Use Area as designated under the Sustainable Use Area (Alphonse Group) (Marine) (Designation) Order, 2023 (S.I. 76 of 2023);
- (b) Amirantes to Fortune Bank Sustainable Use Area as designated under the Sustainable Use Area (Amirantes to Fortune Bank) (Marine) (Designation) Order, 2023 (S.I. 77 of 2023);
- (c) Cosmoledo and Astove Archipelago Sustainable Use Area as designated under the Sustainable Use Area (Cosmoledo and Astove Archipelago) (Marine) (Designation) Order, 2023 (S.I. 78 of 2023);
- (d) Denis Island Sustainable Use Area as designated under the Sustainable Use Area (Denis Island) (Marine) (Designation) Order, 2023 (S.I. 79 of 2023);

- (e) Desroches Atoll Sustainable Use Area as designated under the Sustainable Use Area (Desroches Atoll) (Marine) (Designation) Order, 2023 (S.I. 80 of 2023);
- (f) Farquhar Archipelago Sustainable Use Area as designated under the Sustainable Use Area (Farquhar Archipelago) (Marine) (Designation) Order, 2023 (S.I. 81 of 2023);
- (g) Farquhar Atoll Sustainable Use Area as designated under the Sustainable Use Area (Farquhar Atoll) (Marine) (Designation) Order, 2023 (S.I. 82 of 2023); and
- (h) Poivre Atoll Sustainable Use Area (Poivre Atoll) (Marine) (Designation) Order, 2023 (S.I. 83 of 2023);

“Zone 3” means The Seychelles marine spatial plan multiple use zone as described in the Seychelles MSP Zoning framework set out in Schedule 5 and consists of the Inner Islands area comprising of the Port of Victoria boundary, and the deep water area of the EEZ that is not included in Zone 1 or 2 in the Outer Islands.

### **Purpose of Regulations**

3.(1) The purpose of these regulations shall be to protect a minimum of 30% of the Seychelles' territorial waters and EEZ combined, and Zone 1 and 2 each respectively constituting of a minimum of 15% of the area in order to achieve its National commitment under the Seychelles Marine Spatial Plan.

(2) For the avoidance of doubt it is stated that the Seychelles Marine Spatial Plan shall be from the mean high water mark seaward to the boundary of the Exclusive Economic Zone and the map of the Seychelles Marine Spatial Plan shall be deposited at the documentation centre of the ministry responsible for environment.

### **Application and exemptions**

4.(1) These regulations shall unless specified otherwise be applicable to —

- (a) the areas consisting of Zone 1, Zone 2 designated as marine protected areas in terms of section 5 (1) of the Act; and
- (b) the area classified as Zone 3, consisting of the area demarcated as “Zone 3 area” pursuant to section 32(1) and (2)(c) of the Act:

Provided that, these regulations shall not be applicable to Aldabra Special Reserve, Aride Island Special Reserve, Cousin Island Special Reserve, St. Anne Marine National Park, Baie Ternay Marine National Park, Curieuse Marine National Park, Port Launay Marine National Park, Ile Cocos, Ile La Fouche, Ile Platte Marine National Park and Silhouette Marine National Park.

(2) For the avoidance of doubt it is stated that, nothing in these regulations shall prevent or interfere with —

- (a) the use of sea routes by any vessel in lawful navigation or passage rendered necessary by force majeure or distress or for the purpose of rendering assistance to any person, ship or aircraft in danger or distress, or any other right of passage as specified in Part IV of the Maritime Zones Act, 1999;
- (b) the residents on private land within a Zone 2 Sustainable Use Area from having reasonable access by boat to their property; and
- (c) a public authority performing any act which the public authority considers necessary in relation to public safety or public health where such act is performed without prior consultation with the person managing the sustainable use area.

### **Prohibited Activities in Zone 1**

5.(1) No person shall, in Zone 1 area, engage in any marine activity specified in Column II relating to any sector specified in Column I of the following table —

(2) Any person who contravenes the provisions of sub-regulation (1) commits an offence.

**Activities permitted in Zone 1, subject to conditions**

6.(1) Notwithstanding the provisions of regulation 5, any person may, with the prior written approval of the Minister and in compliance with the following documents, and SMSP Master List of Definitions for Allowable Activities Tables and SMSP Zoning Design General and Area-based Management Considerations (deposited at the documentation centre of the Ministry of the Minister responsible for Environment), engage in Zone 1 in any activity specified in sub-regulation (2) —

- (a) the SMSP zoning design allowable activities table for Zone 1 (Schedule 1); and
- (b) the SMSP Zoning Design Codes for Allowable Activities (Schedule 4).

(2) Subject to sub-regulation (1), any person may engage in any marine activity specified in Column II relating to any sector specified in Column I of the following table —

(3) The conditions specified in sub-regulation (1) shall be considered on a case by case basis.

(4) (a) The Minister shall, when granting approval for any activity specified in sub-regulation (2), comply with any relevant written law and regulation, including any relevant site specific regulations.

(b) The Minister shall, prior to granting approval for any activity specified in sub-regulation (2), consult any other relevant authority including any other relevant Ministry in respect of such approval.

(5) Any person who contravenes the provisions of sub-regulation (1) commits an offence.

(6) Any person engages in any activity in Zone 1 under this regulation knowing or where he ought reasonably to know that such activity —

- (a) causes or may cause alteration, damage or destruction to any property, animal or plant within that Zone; or
- (b) causes or may cause injury to or death of any animal or organism in that Zone, commits an offence.

### Activities prohibited in Zone 2

7.(1) No person shall, in Zone 2 area, engage in any activity specified in Column I described in Column II of the following table —

Maritime infrastructure	(a) Disposal, dumping (b) Reclamation
Non-renewable and prospecting	(a) Mining, deep-sea (b) Mining, sand (c) Mining, shallow

(2) Any person who contravenes the provisions of sub-regulation (1) commits an offence.

### Activities permitted in Zone 2, subject to conditions

8.(1) Notwithstanding the provisions of regulation 7, any person may, with the prior written approval of the Minister and in compliance with the following documents, and the SMSP Master List of Definitions for Allowable Activities Tables and the SMSP Zoning Design General and Area-based Management Considerations (deposited at the documentation centre of the Ministry of the Minister responsible for Environment), engage in Zone 2 in any activity specified in sub-regulation (2) —

- (a) the SMSP Zoning Design Allowable Activities Table for Zone 2 (Schedule 2); and
- (b) the SMSP Zoning Design Codes for Allowable Activities (Schedule 4).

(2) Subject to sub-regulation (1), any person may engage in any marine activity specified in Column II relating to any sector specified in Column I of the following table —

(3) The conditions specified in sub-regulation (1) shall be considered on a case by case basis.

(6) Any person engages in any activity in Zone 2 under this regulation knowing or where he ought reasonably to know that such activity —

(a) causes or may cause alteration, damage or destruction to any property, animal or plant within that Zone; or

(b) causes or may cause injury to or death of any animal or organism in that Zone, commits an offence.

### **Activities permitted in Zone 3, subject to conditions**

9.(1) No person shall, except in compliance with the following documents, and the SMSP Master List of Definitions for Allowable Activities Tables and the SMSP Zoning Design General and Area-based Management Considerations (deposited at the documentation centre of the Ministry of the Minister responsible for Environment), engage in Zone 3 in any activity specified in subregulation (2) —

(a) the SMSP Zoning Design Allowable Activities Table for Zone 3 (Schedule 3); and

(b) the SMSP Zoning Design Codes for Allowable activities (Schedule 4).

(2) Subject to sub-regulation (1), any person may engage in any marine activity specified in Column II relating to any sector specified in Column I of the following table —

(3) The conditions specified in sub-regulation (1) shall be considered on a case by case basis.

(4) Approval for any activity specified in sub-regulation (2) shall be subject to any relevant written law and regulation.

(5) Any person who contravenes the provisions of sub-regulation (1) commits an offence.

(6) Any person engages in any activity in Zone 3 under this regulation knowing or where he ought reasonably to know that such activity —

- (a) causes or may cause alteration, damage or destruction to any property, animal or plant within that Zone; or
- (b) causes or may cause injury to or death of any animal or organism in that Zone, commits an offence.

### **Jurisdiction**

**10.** For the purposes of these regulations, Jurisdiction shall have the same meaning assigned by the Maritime Zones Act, 1999;

## Offences and Penalty

11.(1) Any person who commits an offence under these regulations, shall, if such offence is specified in the Act, be liable on conviction to the same penalty specified in the Act for the offence.

(2) If a penalty is not specified in the Act in respect of any offence specified in these regulations, a person who commits such offence shall, on conviction be liable to a fine of level 5 on the Standard Scale or imprisonment for a term not exceeding 5 years.

Stakeholders have developed and refined the restrictions and codes, starting in 2015. See also the General and Area-based Management Considerations and the Master List of Definitions.

1	See General and Area -based Management Consideration s. Approved management plans needed for Zone 1 and Zone 2 areas including Environmental Impact Assessment (EIA) and/or Environmental and Social Impact Assessment (ESIA), where applicable or required. Development proposals require a transparent and participatory process with all stakeholders.
2	For subsistence fishing, the management plan for the area will provide direction on the meaning of, the conditions, and definition of the activities it would apply to, noting the intent of subsistence fishing for persons residing on the islands. Subsistence fishing would be allowable for residents of Outer Islands. The details of subsistence fishing can be done at the technical level alongside or after the MSP is approved. Quotas and monitoring of all species harvested is required. Sustainable yield would need to be determined in a Zone 1 (SFA). Definition and regulations of subsistence fishing are as per the Seychelles Fisheries and Aquaculture Bill 2025 and regulation(s). See also notes in General Management Considerations.
3	Anchor in designated areas and/or use permanent mooring buoys as required by legislation, regulation, management plans or policy, and/or where practical.
4	Restrictions may apply to avoid or minimise disturbance on key species and ecological functions. For fisheries activities, see relevant legislation, regulations, and agreements for restrictions on target and non-target species.
5	Authorised approved permit and/or licenses are required for research and monitoring activities, where applicable.

8	For non-renewable and bioprospecting activities, exploration and development phases must adhere to strict standards for the sector incl. health, safety, and environment. Petroleum activities must comply with Petro Seychelles Model Petroleum Agreement.
9	Motorised devices and motor watercraft (jet skis) are prohibited in all SMSP Marine National Parks (Zone 1) and in the Desroches, Poivre, Alphonse, and Farquhar Atoll SMSP Marine Sustainable Use Areas (Zone 2; see Outer Islands Project) except where authorised for research, essential access and/or infrastructure, enforcement, safety and/or rescue. See the SMSP Master List of Definitions for motor watercraft and motorised devices. Motor watercraft (jet skis) should not operate within reef zones 150 m from high water mark as per international best practice. All other motorised devices are prohibited in Zone 2.

11	The type and extent of activities offered by a Hire Craft licence may be limited, depending on the area objectives.
